Ladies and Gentlemen:

FOR VALUE RECEIVED, the undersigned, **BANK OF AMERICA, N.A.**, a national banking association and successor-by-merger to NationsBank N.A., a national banking association ("Secured Party"), as agent for various lenders, does hereby terminate and release any and all security interests in or liens upon the trademark registrations and trademark application shown on Schedule 1 attached hereto, arising under that certain Security Agreement dated as of December 28, 2001, as amended by that certain Amended and Restated Security Agreement dated as of December 23, 2005 (the "Security Agreement"), among Secured Party, Applica Consumer Products, Inc. ("ACP"), a Florida corporation and successor-by-merger to HP Intellectual Corp. ("HPI"), a Delaware corporation, and the other parties named therein as Obligors.



Secured Party and HPI subsequently entered into a certain Notice of Grant of Security Interest in Trademarks (the "HPI-4 Notice") that was recorded with the PTO on September 15, 2005, at Reel 3197, Frame 0988. Secured Party and ACP entered into a certain Notice of Grant of Security Interest in Trademarks (the "ACP Notice"; the HPI-1 Notice, HPI-2 Notice, HPI-3 Notice, HPI-4 Notice and ACP Notice are herein collectively referred to as the "Notices") that was recorded with the PTO on December 14, 2004, at Reel 2993, Frame 0160.

Secured Party and ACP hereby acknowledge and agree that, except with respect to those trademarks listed on Schedule 1 attached hereto, this notice shall not serve to terminate Secured Party's security interests or liens upon any other trademarks referred to in any of the Notices.
