RELEASE OF SECURITY INTEREST

WHEREAS, Teltronics, Inc. ("Teltronics") entered into a certain Loan and Security Agreement dated October 28, 1994 (as amended, the "Security Agreement") in favor of The CIT Group/Business Credit, Inc., a New York corporation formerly known as The CIT Group/Credit Finance, Inc. (the "Secured Party"), to secure payment of certain obligations of Teltronics to the Secured Party; and

WHEREAS, an executed copy of the Security Agreement was recorded by the Assignment Division of the United States Patent and Trademark Office on Reel 1266, Frame 0016 on November 1, 1994; and

WHEREAS, Teltronics has requested that the Secured Party release its security interest in **the trademark applications and registrations described in Annex 1 attached hereto (hereinafter referred to, collectively as the "Trademarks")**, and the goodwill associated therewith, granted to such Secured Party pursuant to the Security Agreement;


NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Secured Party hereby:

1. releases any and all liens, security interest, right, title and interest in the **Trademarks**, and the goodwill associated therewith, granted to such Secured Party pursuant to the Security Agreement, without recourse or representation or warranty, express or implied; and
2. authorize and request the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release of the **Trademarks** hereby given by this instrument.

This instrument may be executed on separate counterparts each of which shall be an original, but all of which together shall constitute one and the same instrument.
