**TERMINATION AND RELEASE OF TRADEMARK AND TRADEMARK APPLICATIONS SECURITY AGREEMENT**, dated as August 29, 2005 by **BANK OF AMERICA, N.A.**, as Collateral Agent (in such capacity, the "Agent"), with an office at 40 Broad Street, Boston, Massachusetts 02109 and KB Holdings, LLC, a limited liability company organized under the laws of Nevada (the "Grantor"). Capitalized terms used but not defined herein shall have the meanings ascribed to them in the Credit Agreement dated as of August 29, 2005 by and between Agent, the Lenders party thereto and the Borrowers.

**WHEREAS**, the Grantor and the Agent entered into a Trademark and Trademark Applications Security Agreement, dated as of August 29, 2005 (the "Agreement"), which Agreement was recorded November 18, 2005, with the United States Patent and Trademark Office at Reel 3224, Frame 0309 for the purpose of securing payment and performance of Obligations of the Borrowers;

**WHEREAS**, as the Obligations have been paid in full, the Agent has agreed to terminate and release the Agreement and the security interests granted to the Agent in the trademarks listed on Exhibit A attached hereto;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates and releases the Agreement and the security interests granted to the Agent in and to the trademarks listed on Exhibit A attached hereto, effective as of the date set forth above.
