**Grant of First Lien Security Interest
in United States Patents and Trademarks**

This **FIRST LIEN PATENT AND TRADEMARK SECURITY AGREEMENT** dated as of June 1, 2007 (as amended, restated, supplemented or otherwise modified from time to time, this "Agreement"), made by each of the signatories hereto (together with any other entity that may become a party hereto as provided herein, the "Grantors"), in favor of Bank of America, N.A. with offices at 1455 Market Street, 5th Floor, Mail Code: CA5-701-05-19, San Francisco, CA 94103 ("Bank of America"), as collateral agent (the "Collateral Agent") for the First Lien Secured Parties.

WHEREAS, the Grantors, the Lenders party thereto from time to time (the "Lenders"), Bank of America, as collateral agent, and certain other parties as named therein have entered into a First Lien Credit Agreement, dated as of June 1, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, it is a condition precedent to the obligation of the Lenders to make their respective extensions of credit to the Grantors under the Credit Agreement that the Grantors shall have executed and delivered that certain First Lien Security Agreement dated as of June 1, 2007 (the "Security Agreement") between the Grantors and the other grantors party thereto and the Collateral Agent; and

WHEREAS, under the terms of the Security Agreement, the Grantors have granted a security interest in certain property, including, without limitation, certain Intellectual Property of the Grantors to the Collateral Agent for the ratable benefit of the First Lien Secured Parties, and have agreed as a condition thereof to execute this Agreement for recording with the United State Patent & Trademark Office;

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantors and the First Lien Secured Parties hereby agree as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, capitalized terms have the meaning given to them in the Security Agreement;

SECTION 2. Grant of Security Interest in Patent and Trademark Collateral. The Grantors hereby pledge and grant to Collateral Agent, for the benefit of the First Lien Secured Parties, a security interest and continuing lien on all of the Grantors' right, title, and interest in, to, and under the following, whether now owned or existing or hereafter acquired or arising and wherever located (collectively, the "Patent and Trademark Collateral"):

a. each United States patent and patent application, including each Patent and Patent Application referred to on Schedule A hereto, and all reissues, reexaminations, divisions, continuations, continuations-in-part, revisions, renewals or extensions thereof,

b. each United States trademark, trademark registration, trademark application, service mark, service mark registration, and service mark application (but excluding in all cases all intent-to-use trademark applications for which a Statement of Use or an Amendment to Allege Use in connection therewith has not been filed and accepted by the United

States Patent and Trademark Office) and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, trademark application, service mark, service mark registration, and service mark application, including each United States Trademark referred to on Schedule B, and any extensions and renewals of any of the foregoing,

c. Trademark Licenses and Patent Licenses other than the Excluded Contracts, and


d. all products and proceeds of the foregoing, including any claim by the Grantor against third parties for past, present or future infringement of any Patent, or past, present or future infringement or dilution of any Trademark, including any Patent or Trademark listed on Schedule A or B hereto, or for injury to the goodwill associated with any Trademark

SECTION 3. In the event that any provisions of this Agreement are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.




