## RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated July 11, 2007 by HARRIS N.A. ("*Harris*"), as administrative agent as hereinafter described, with its main office and mailing address at 111 West Monroe Street, Chicago, Illinois 60603 (Harris acting as such Administrative Agent hereinafter referred to as the "*Administrative Agent*");

### WITNESSETH:

WHEREAS, Axis Capital, Inc., a Nebraska corporation (the "*Debtor*") with its mailing address and principal place of business at 308 N. Locust St., Grand Island, Nebraska 68801, granted to the Administrative Agent, acting as administrative agent for itself and certain other Secured Creditors identified and defined in that certain Trademark Collateral Agreement dated August 23, 2005 between the Debtor and the Administrative Agent which was recorded in the United States Patent and Trademark Office on August 25, 2005 at Reel 003146, Frame 0939 (the "*Agreement*"), pursuant to the Agreement, a security interest in and collateral assignment of the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and

WHEREAS, the Debtor has requested that the Administrative Agent release its security interests in the Trademark Property and reassign the same to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


The Administrative Agent hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Administrative Agent, all of its right, title and interest, if any, in and to:

(i) Each trademark, trademark registration and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) All proceeds of the foregoing, including without limitation any claim by the Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark application, in each case together with the right to sue for and collect said damages.
