**RELEASE OF SECURITY INTEREST**

This Release of Security Interest is made as of July 27, 2007, by Bank of America National Trust and Savings Association, located at 1850 Gateway Boulevard, Concord, California 94520, as Administrative Agent ("ADMINISTRATIVE AGENT"), in favor of Kinetic Concepts, Inc., a Texas corporation, KCI Holding Company, Inc., a Delaware corporation, KCI New Technologies, Inc., a Delaware corporation, Plexus Enterprises, Inc., a Delaware corporation, Medical Retro Design, Inc., a Delaware corporation, KCI Properties Limited, a Texas corporation, KCI-RIK Acquisition Corp., a Delaware corporation, KCI Therapeutic Services, Inc., a Delaware corporation, KCI Real Property Limited, a Texas corporation, KCI International, Inc., a Delaware corporation, and KCI, Air, Inc., a Delaware corporation, all located at 8023 Vantage Drive, San Antonio, Texas 78265 (collectively referred to as "COMPANY").
