RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release") is given as of this 31st day of July, 2007, by INTERSTATE FIBERNET, INC., a Delaware corporation, located at located at 7037 Old Madison Pike, Suite 400 Huntsville, Alabama 35806, as Borrower, on behalf of MORGAN STANLEY & CO. INCORPORATED, in its capacity as Collateral Agent for the Secured Parties (together with its successors in such capacities, the "Assignor"), in favor of INTERSTATE FIBERNET, INC., a Delaware corporation, located at located at 7037 Old Madison Pike, Suite 400 Huntsville, Alabama 35806, ITC^DELTACOM, INC., a Delaware corporation, located at located at 7037 Old Madison Pike, Suite 400 Huntsville, Alabama 35806, and ITC^DELTACOM COMMUNICATIONS INC., an Alabama corporation, located at located at 7037 Old Madison Pike, Suite 400 Huntsville, Alabama 35806, (together, "Assignee").

Capitalized terms used in this Release, but not defined herein, shall have the respective meanings ascribed to them in the Intellectual Property Security Agreement or Credit Agreement referred to below, as applicable.

WHEREAS, Interstate FiberNet, Inc., the Lender Parties, and the Agents names therein entered into a Credit Agreement, dated as of April 5, 2000 ("Initial Credit Agreement") and the Loan Parties, the Lender Parties and the Agents entered into an Amended and Restated Credit Agreement, dated as of October 29, 2002 (as at any time amended, the "Credit Agreement"), and Assignor and Assignee entered into that certain Amended and Restated Intellectual Property Security Agreement, dated as of October 29, 2002 (as at any time amended, the "Intellectual Property Security Agreement");

WHEREAS, the Intellectual Property Security Agreement was recorded with the U.S. Patent and Trademark Office on December 4, 2002, at Reel 2627/Frame 0069;

WHEREAS, pursuant to the Credit Agreement and the Intellectual Property Security Agreement, Assignee granted to Assignor, for the ratable benefit of the Secured Parties, a security interest in and to all of Assignee's right, title and interest in and to the Collateral, including the patents and patent applications, trademark and service mark registrations and applications, and copyright registrations and applications listed on Exhibit A hereto, in each case, whether then existing or thereafter created or acquired;

WHEREAS, the Parties desire that Assignor terminate and release its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby terminates and releases its continuing security interest in all, right, title and interest in and to the Collateral, and reassigns any and all interest that it may have therein to Assignee.


Assignor hereby authorizes Assignee or Assignee's authorized representative to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC Financing Statement Amendments with the applicable filing office in order to memorialize the release of any security interest of Assignor in the Trademark Collateral, and/or (iii) otherwise file this Release.
