**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release"), dated as of August 1, 2007 by **BANK OF AMERICA, N.A.**, ("Bank of America"), a national association with a place of business at 100 Federal Street, Boston Massachusetts 02110, in connection with the grant of security interests in certain trademarks by **WORLD ENERGY ALTERNATIVES, LLC**, a limited liability company organized under the laws of the State of Delaware (the "Assignor") in favor of Bank of America.

WITNESSETH:

WHEREAS, the Assignor entered into an agreement with Bank of America which was recorded in the Trademark Division of the United States Patent and Trademark Office on November 14, 2005 at Reel 3193, Frame 0729 for the purpose of providing certain trademarks as collateral security for the payment and performance of certain obligations of the Assignor to Bank of America; and

WHEREAS, Bank of America now desires to terminate and release the entirety of its security interest in the Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank of America hereby agrees as follows:

1. Definitions. The term "***Trademark Collateral***", as used herein, shall mean all of the Assignor's right, title and interest of every kind and nature as of the date hereof in the Assignor's trademarks (including, without limitation, those items listed on Schedule A thereto).

2. Release of Security Interest. Bank of America hereby terminates, releases and discharges its security interest in the Trademark Collateral without representation, warranty or recourse of any kind or nature.
