**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of August 16, 2007, is made by Bear Stearns Corporate Lending Inc. ("Bear Stearns"), in favor of Linread Public Limited Company ("Linread") as follows:




