**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of August 16, 2007, is made by Bear Stearns Corporate Lending Inc. ("Bear Stearns"), in favor of Linread PLC ("Linread") as follows:

**WITNESSETH**

WHEREAS, pursuant to the Security Agreement, dated May 11, 2007 ("Security Agreement"), and recorded with The United States Patent and Trademark Office on May 15, 2007 at Reel/Frame No. 3542/0127, Linread granted Bear Stearns a security interest in and to all of its right, title and interest in its trademarks and all applications and registrations therefor, including goodwill (the "Trademark Collateral");


Bear Stearns agrees to provide Linread with any information and additional authorization necessary to effect the release of Bear Stearns's security interest in the released Trademark Collateral.


