**PARTIAL RELEASE**  
**OF**  
**AMENDED AND RESTATED TRADEMARK AND PATENT SECURITY**  
**AGREEMENT**

WHEREAS, Dorskocil Manufacturing Company, Inc., a Texas corporation ("**Borrower**"), Aspen Pet Products Holdings, Inc., a Delaware corporation, and Aspen Pet Products, Inc., a Delaware corporation (collectively, the "**Pledgors**") are the owners of certain patents and applications therefor (the "**Patents**") and trademarks and registrations therefor (the "**Trademarks**") including but not limited to those listed on Schedule A hereto and the goodwill of the Pledgors' businesses associated therewith; and

WHEREAS, pursuant to a certain Amended and Restated Trademark and Patent Security Agreement dated as of January 31, 2006, between the Pledgors and Bank of America, N.A., as Agent (the "**Agent**"), and recorded with the United States Patent and Trademark Office on April 25, 2006 at Reel/Frame 003296 / 0577 and at Reel/Frame 017519 / 0594, the Pledgors granted to the Agent, inter alia, a security interest in and to certain Trademarks and Patents, the registrations thereof, and the goodwill associated therewith, including but not limited to those listed on Schedule A; and

WHEREAS, the parties now desire to terminate the Agent's security interest solely as to the Trademarks and Patents listed on Schedule A.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and other good and valuable consideration and intending to be legally bound hereby, the Agent hereby agrees as follows:


Effective as of the date hereof, the Agent hereby releases its security interest and conveys back to the Pledgors all of the Agent's interest solely as to the Trademarks and Patents listed on Schedule A, and the registrations thereof and the goodwill associated therewith.

Except as expressly set forth herein, the execution, acknowledgement or delivery of this instrument by the Agent does not constitute a waiver or release of any indebtedness or other obligation on the part of Pledgors under any document, instrument or agreement secured by or described in the Amended and Restated Loan and Security Agreement dated as of January 31, 2006, among Borrower, the lenders party thereto, Agent, and Ableco Finance LLC, a Delaware limited liability company, as Term Loan B Agent, or a waiver of any default or event of default or of any right, power, privilege or remedy on the part of Pledgors under any such document, instrument or agreement.
