## RELEASE OF LIEN AND SECURITY INTEREST

This Release of Intellectual Property Security Agreement ("Release"), is made by Wachovia Bank, N.A. ("Wachovia") in favor of DG FastChannel, Inc. (formerly Digital Generation Systems, Inc.), a Delaware corporation ("DG FastChannel") and its subsidiaries and Pathfire, Inc., a Georgia corporation ("Pathfire").

### RECITALS

WHEREAS, Wachovia and DG FastChannel previously entered into that certain Intellectual Property Security Agreement dated May 31, 2006, recorded in the United States Patent and Trademark Office on July 14, 2006 at Reel 017931, Frame 0139 for Patents, and Reel 3354, Frame 0379 for Trademarks (the "DG FastChannel Security Agreement"), pursuant to which Wachovia purportedly owns a security interest in, among other things, DG FastChannel's Intellectual Property (as defined in the DG FastChannel Security Agreement), including the intellectual property of DG FastChannel associated with such DG FastChannel Security Agreement that are listed in the attached Exhibit A.

WHEREAS, Wachovia Bank and Pathfire previously entered into that certain Intellectual Property Security Agreement dated June 7, 2007, recorded in the United States Patent and Trademark Office on August 8, 2007 at Reel 019663, Frame 0651 for Patents, and Reel 3596, Frame 0602 for Trademarks (the "Pathfire Security Agreement"), pursuant to which Wachovia purportedly owns a security interest in, among other things, Pathfire's Intellectual Property (as defined in the Pathfire Security Agreement), including the intellectual property of Pathfire associated with such Pathfire Security Agreement that are listed in the attached Exhibit B.

WHEREAS, Wachovia desires to release its security interest in the DG Fast Channel Intellectual Property and the Pathfire Intellectual Property, including the intellectual property listed in the attached Exhibit A and Exhibit B.

**NOW, THEREFORE, subject to the terms, conditions, covenants and provisions of this Release, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:**

Wachovia hereby releases all liens, security interests, assignments, and other interests of Wachovia in and to the intellectual property of DG FastChannel and Pathfire, including, without limitation, the security interest in the Intellectual Property listed on the attached Exhibit A and Exhibit B.

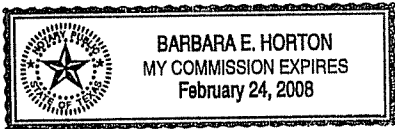
