NOTICE OF SECURITY INTEREST IN U.S. TRADEMARKS

This Notice has been issued in conjunction with the security interest granted to the Secured Party under the Security Agreement. The rights and remedies of the Secured Party with respect to the Security Interest are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Notice are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

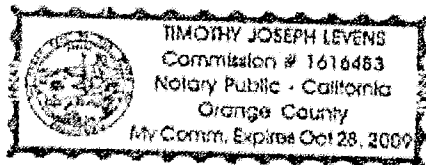
