PARTIAL RELEASE OF AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT

This PARTIAL RELEASE OF AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT is executed as of September 12, 2007 by Bank of America, N.A., in its capacity as Collateral Agent (the "Agent") under that certain Amended and Restated Credit Agreement dated as of September 27, 2006 (as amended, and as the same may be further amended, supplemented or otherwise modified, the "Credit Agreement") among Marsh Supermarkets, LLC, as Borrower, the other Borrowers named therein, the Lenders named therein and Agent.

WHEREAS, pursuant to the Credit Agreement, Village Pantry, LLC (the "Grantor") executed and delivered to the Agent the Amended and Restated Intellectual Property Security Agreement dated as of September 27, 2006 and recorded on October 24, 2006 at reel 3414, frame 0883, as amended by that certain First Amendment and Joinder to Amended and Restated Intellectual Property Security Agreement dated as of May 25, 2007 (the "Intellectual Property Security Agreement");

WHEREAS, pursuant to the Intellectual Property Security Agreement, the Grantor has granted to the Agent, as security for the Obligations (as defined in the Credit Agreement), a continuing security interest in all of the Grantor's right, title and interest in and to that certain trademarks listed on Exhibit A attached hereto (the "Released Trademarks"); and

WHEREAS, in connection with that certain Second Amendment to the Amended and Restated Credit Agreement dated as of May 25, 2007, the Grantor has requested that the Agent release the liens and security interests granted to the Agent by the Grantor with respect to the Grantor's right, title and interest in and to the Released Trademarks (to the extent of the Grantor's interest therein) pursuant to the Intellectual Property Security Agreement or otherwise.

For good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby:

(a) releases the liens and security interests granted by the Grantor to the Agent pursuant to any security agreement (including but not limited to the Intellectual Property Security Agreement) in the right, title and interest of the Grantor in and to the Released Trademarks solely to the extent of the Grantor's interest therein; and

(b) to the extent the Agent shall be deemed to have any right, title or interest in the Released Trademarks, retransfers and reassigns to the Grantor all of such right, title and interest solely with respect to the Released Trademarks.

Except as expressly modified hereby, the Intellectual Property Security Agreement shall remain in full force and effect in accordance with the provisions thereof on the date hereof.

Capitalized terms used herein and not otherwise defined shall have the meanings given such terms in the Intellectual Property Security Agreement.

This Partial Release of Intellectual Property Security Agreement shall be governed by the laws of the State of New York.


