TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Trademark Assignment") is entered into on 9/12, 2007, by and between THE GOLDEN GROUP I, INC., a corporation incorporated under the laws of Colorado ("Assignor"), and JUPITERMEDIA CORPORATION, a corporation organized under the laws of Delaware ("Assignee").

WHEREAS, Assignor owns fifty and one tenth percent (50.1%) right, title and interest in and to the Trademarks (as defined below), and Assignee owns forty nine and nine tenth percent (49.9%) right, title and interest in and to the Trademarks (as defined below);

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement, dated as of January 25, 2007 (the "Purchase Agreement"), pursuant to which Assignor agreed to sell, grant and transfer to Assignee all of Assignor's right, title and interest to the Assets (as defined in the Purchase Agreement) including, without limitation, the marks listed on the attached Schedules A and B, all applications and registrations pertaining, thereto, and all common law rights associated therewith, together with all goodwill arising from the use of and symbolized by said marks, all such rights existing in any jurisdiction (collectively, the "Trademarks"); and

WHEREAS, the Assignor and Assignee desire to carry out the intent and purpose of the Purchase Agreement by the execution and delivery of this instrument evidencing the sale, conveyance, assignment and transfer to the Assignee of all rights, title and interest of the Assignor in and to the Trademarks, whereby, Assignee shall be the sole and exclusive owner of one hundred percent (100%) right, title and interest in and to the Trademarks.

NOW THEREFORE, in consideration for the sum of ten (\$10) dollars and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto enter into this agreement as follows:

1. Assignor does hereby confirm, *nunc pro tunc*, that on January 25, 2007 Assignor did sell, grant and transfer to Assignee, its successors and assigns, all of Assignor's right, title and interest in and to each of the Trademarks throughout the world, including the right to conduct business under the Trademarks, the right to license others under the Trademarks, the portion of the business of Assignor to which any intent-to-use application pertains, together with the right to sue, counterclaim and recover damages and profits and all other remedies for claims of past, present and future infringement or misappropriation thereof, and all income, royalties, damages, and payments now or hereafter due or payable with respect to the Trademarks.

2. Assignor hereby sells, grants, transfers and quit-claims to Assignee, its successors and assigns, any and all residual and remaining right, title and interest Assignor has had, has and may have acquired to INBOX THE EMAIL EVENT ("INBOX") (on Schedule A)

throughout the world, including the right to conduct business under INBOX, the right to license others under INBOX, the portion of the business of Assignor to which any intent-to-use application pertains, together with the right to sue, counterclaim and recover damages and profits and all other remedies for claims of past, present and future infringement or misappropriation thereof, and all income, royalties, damages, and payments now or hereafter due or payable with respect to INBOX.

3. Assignor hereby agrees to execute, at Assignee's expense, such additional documents as Assignee may request to register and otherwise give full effect to and perfect the rights of Assignee under this Trademark Assignment in and to the Trademarks worldwide, including all documents necessary to register in the name of Assignee the assignment of the Trademarks with the United States Patent & Trademark Office and, with respect to any equivalent foreign rights, with any other appropriate foreign or international office or registrar.

4. General Provisions.

In the event that any provision of this Agreement shall be construed to conflict with a provision of the Purchase Agreement, the provision in the Purchase Agreement shall be deemed controlling.

This Agreement shall be construed and enforced in accordance with the laws (other than the conflict of law rules) of the State of New York.

This Agreement shall bind and shall inure to the benefit of the respective parties and their assigns, transferees and successors.

This Agreement may be executed in one or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument.


