

## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 25, 2007, is made by Bank of America, N.A., as Administrative Agent (the "Secured Party").
