The Collateral Agent acknowledges and agrees that, as a result of this Termination and Release of Security Interest in Intellectual Property, the Released IP Collateral is automatically reconveyed to the Grantors, The Collateral Agent further acknowledges and agrees that it has no further rights to or interest in the Released IP Collateral under the Security Agreements.

3. Further Assurances. The Collateral Agent hereby agrees, at the Grantors' expense, to execute such instruments and to take such other actions as the Grantor may reasonably request to terminate the Collateral Agent's security interest in the Released IP Collateral, and otherwise to effectuate the release of the Released IP Collateral from the Collateral Agent's security interest.

4. Governing Law. This Termination and Release of Security Interest in Intellectual Property shall be governed by, and construed in accordance with, the laws of the State of New York.

5. Recordation. The Collateral Agent hereby authorizes and requests the governing body of each of the United States Patent and Trademark Office and the United States Copyright Office to record this termination and release of security interest in the Released IP Collateral.

6. Execution in Counterparts. This Termination and Release of Security Interest in Intellectual Property may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
