WHEREAS, Option Care executed in favor of LaSalle that certain Trademark Security Agreement dated as of May 5, 2006 (a copy of which is attached hereto as Exhibit 1), pursuant to which Option Care assigned and granted to LaSalle a certain security interest in and to, *inter alia*, all of Option Care's right, title and interest in, to and under all now owned and hereafter acquired trademarks, trademark registrations, trademark applications, trade names, brands, names, logos, designs, trade dress and designations of origin owned by or on behalf of Option Care, and trademark licenses, including but not limited to those referred to in Schedule 1 attached to Exhibit 1 (hereinafter collectively referred to as the "Secured Property"); and

WHEREAS, such Trademark Security Agreement dated as of May 5, 2006, was recorded at the Assignment Branch of the U.S. Patent and Trademark Office at Reel No. 003306, Frame No. 0049, on May 10, 2006; and

WHEREAS, LaSalle acknowledges and agrees that all of Option Care's obligations with respect to the Guaranty and Collateral Agreement and the Trademark Security Agreement, both dated as of May 5, 2006, have now been fully and completely satisfied and that the security interest granted therein has been and hereby is terminated;

WHEREAS, LaSalle desires to fully, completely and formally release its entire security interest in and to the Secured Property and in and to any and all other trademarks owned by or on behalf of Option Care and the goodwill associated therewith or relating thereto, and to record such release with the U.S. Patent and Trademark Office;

NOW THEREFORE, in consideration of the foregoing recitals and representations, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, LaSalle does hereby fully, completely and formally release and reconvey to Option Care any and all of LaSalle's right, title and interest in, to and under the Secured Property, and all goodwill associated therewith or relating thereto, and in and to any and all other trademarks owned by or on behalf of Option Care.

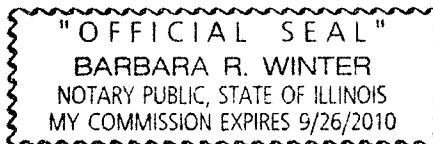

## TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of May 5, 2006, by OPTION CARE, INC., a Delaware corporation (the "Grantor"), in favor of LASALLE BANK NATIONAL ASSOCIATION, in its capacity as administrative agent for the Lenders (in such capacity, the "Administrative Agent").

### RECITALS

A. The Grantor and/or its affiliates have entered into a Credit Agreement dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") with various financial institutions and the Administrative Agent, pursuant to which such financial institutions have agreed to make loans to, and issue or participate in letters of credit for the account of, Grantor and/or its affiliates.

B. The Grantor has entered into a Guaranty and Collateral Agreement dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Collateral Agreement") with the Administrative Agent pursuant to which certain obligations owed to the Lenders are secured.

C. Pursuant to the Guaranty and Collateral Agreement, the Grantor is required to execute and deliver to the Administrative Agent, for the ratable benefit of the Lenders, this Agreement.

D. Capitalized terms used but not defined herein have the respective meanings ascribed thereto in the Guaranty and Collateral Agreement.

Upon Payment in Full, the Administrative Agent shall promptly execute, deliver and/or file any and all releases reasonably requested by Grantor as may be necessary to release the security interests created by this Agreement.




