**TERMINATION AND RELEASE OF SECURITY INTERESTS  
IN TRADEMARKS**

WHEREAS, UNOVA Industrial Automation Systems, Inc., a Delaware corporation (the "Company"), entered into a Collateral Assignment of Security Interest in Trademarks and Licenses, dated as of September 30, 2004 (as from time to time amended, modified or supplemented, the "Collateral Assignment of Trademarks") between the Company and KeyBank National Association, as Administrative Agent, pursuant to which the Company granted a security interest (the "Security Interest") in certain trademarks, including without limitation the trademarks set forth on the attached Schedule A (the "Trademarks"); and

WHEREAS, all of the secured obligations have been fully paid and satisfied and the Administrative Agent desires to release the Security Interest.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases the Security Interest, and hereby, (i) waives and relinquishes all its rights, powers, privileges and remedies under the Collateral Assignment of Trademarks, (ii) sells, assigns, conveys, transfers and sets over to the Company any right, title or interest that the Administrative Agent may have acquired and re-vests in the Company the full unencumbered title to the Trademarks and the goodwill associated therewith, and (iii) releases the Company from all covenants, obligations, liabilities and warranties under the Collateral Assignment of Trademarks.
