RELEASE OF SECURITY INTEREST IN TRADEMARKS
(CIT / JPSLLC)

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the "Release") is made and effective as of the date indicated below and is granted by THE CIT GROUP/BUSINESS CREDIT, INC., as administrative agent ("Releasor") under the Financing Agreement referred to below, in favor of JP SAFETY, LLC ("Releasee", formerly known as TMT-Pathway, L.L.C.).

WHEREAS, pursuant to that certain Second Amended and Restated Financing Agreement, dated July 1, 2005, entered into by Releasor as administrative agent, syndication agent, and co-lead manager, the Releasor and the other parties thereto as lenders (the "Lenders"), and Jackson Products, Inc. ("JPI"), Releasee and each other signatory thereto identified to be a "Company" (JPI, Releasee and each such other Company being herein referred to as "Companies") (as thereafter amended from time to time, the "Financing Agreement"), the lenders agreed to make loans and other financial accommodations to the Companies;

WHEREAS, Releasor and Releasee entered into that certain Trademark Security Agreement dated as of February 11, 2004 (as recorded at the U.S. Trademark Office at Reel 2920, Frame 0716), as amended by (i) that First Amendment to Trademark Security Agreement, dated August 27, 2004 (unrecorded) and (ii) amended and restated by that certain Amended and Restated Trademark Security Agreement, dated as of June 1, 2005 (unrecorded) (as so amended, the "Security Agreement");

WHEREAS, Releasee has requested that Releasor release and discharge fully its security interest in and to that portion of the Trademark Collateral listed on Schedule A hereto (the "Scheduled Collateral") conveyed to Releasor pursuant to the Security Agreement and/or any other agreement (the "Security Interest"); and

WHEREAS, Releasor is willing to release and discharge fully the Security Interest in the Scheduled Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Releasor, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully the Security Interest in the Scheduled Collateral and Releasor hereby reassigns any and all such right, title and interest that it may have in the Scheduled Collateral (if any) to Releasee.

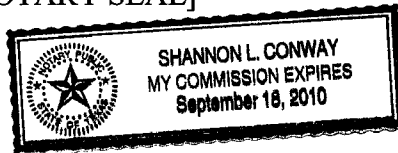
