RELEASE AND REASSIGNMENT

THIS **RELEASE AND REASSIGNMENT** is made this 4th day of October, 2007 by **LASALLE BUSINESS CREDIT, LLC** ("Lender").

WITNESSETH:

WHEREAS, Lender and Madison-Kipp Corporation a Delaware corporation ("Borrower") are parties to a certain Amended and Restated Loan and Security Agreement dated as of March 2, 2005 as it may be amended, amended and restated or otherwise modified from time to time (the "Loan Agreement") pursuant to which Lender made certain loans and other financial accommodations (the "Loans") to Borrower. As partial security for Borrower's Liabilities, as that term is defined in the Loan Agreement, Borrower has executed a certain Trademark Security Agreement (the " Trademark") dated as of March 2, 2005, pursuant to which Borrower granted a security interest in and to the Trademarks, as is defined below; and

WHEREAS, the Trademark was recorded in the United States Patent and Trademark Office on March 10, 2005 at Patent Reel 003044, Frames 0113; and

WHEREAS, the Liabilities have been fully satisfied and, therefore, Borrower has requested that Lender release its security interest in the Trademarks and reassign the same to Borrower.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Lender hereby releases its security interest in all of Borrower's right, title and interest in and to all of its now owned or existing and filed and hereafter acquired or arising and filed:


(a) trademarks, trademark registrations, tradenames and trademark applications, including, without limitation, the trademarks and applications listed on Schedule B, attached hereto and made a part hereof, and (a) renewals and extensions thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including without limitation, damages and payments for past or future infringements thereof, (c) the right to sue for past, present and future infringements thereof, and (d) all rights corresponding thereto throughout the world (all of the foregoing trademarks, trademark registrations, tradenames and applications, together with the items described in clauses (a)-(d) of this subparagraph, are hereinafter referred to as the "Trademarks"); and

(b) the goodwill of Borrower's business connected with and symbolized by the Trademarks.

2. Lender hereby reassigns, grants and conveys to Borrower, without any representation, recourse or undertaking by LaSalle, all of LaSalle's rights, title and interest, in and to the Trademarks.
