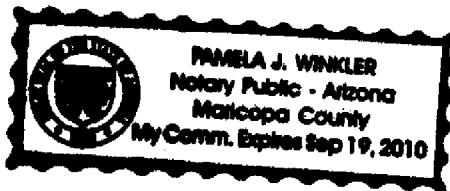

TRADEMARK ASSIGNMENT AGREEMENT






