Pursuant to Section 7.06 of the Amended and Restated Second Lien Credit Agreement dated as of March 16, 2005, as amended by Amendment No. 1 dated as of March 17, 2006 and Amendment No. 2 dated as of August 31, 2007 (said Amended and Restated Credit Agreement as so amended, the "Credit Agreement") among Ascend Media Holdings, LLC, a Delaware limited liability company, Medical World Communications, Inc., a Delaware corporation, the lenders party thereto (the "Lenders"), and Wells Fargo Bank, National Association, as administrative agent and collateral agent (the "Resigning Agent"), the Lenders hereby notify you that (i) the resignation of the Resigning Agent as (A) Administrative Agent and Collateral Agent under the Credit Agreement, (B) Collateral Agent under the Security Agreement and the Intellectual Property Security Agreement and (C) Administrative Agent and Collateral Agent under the Intercreditor Agreement is effective as of the date hereof, (ii) the Lenders hereby appoint The Bank of New York as (A) successor Administrative Agent and Collateral Agent under the Credit Agreement, (B) successor Collateral Agent under the Security Agreement and Intellectual Property Security Agreement and (C) successor Administrative Agent and Collateral Agent under the Intercreditor Agreement effective as of the date hereof and (iii) The Bank of New York hereby accepts its appointment as (A) successor Administrative Agent and Collateral Agent under the Credit Agreement, (B) successor Collateral Agent under the Security Agreement and Intellectual Property Security Agreement and (C) successor Administrative Agent and Collateral Agent under the Intercreditor Agreement effective as of the date hereof.

The Lenders hereby acknowledge that, notwithstanding anything to the contrary contained in the Loan Documents, The Bank of New York, as successor Administrative Agent and Collateral Agent, shall not be required to exercise any discretion under the Loan Documents except upon the instructions of the Required Lenders or (where so specified) all Lenders.

Unless otherwise defined, terms used in the Credit Agreement are used herein as therein defined.







SECOND LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT

Dated January 31, 2005

Notwithstanding anything herein to the contrary, the lien and security interest granted to the Collateral Agent pursuant to this Agreement and the exercise of any right or remedy by the second lien collateral agent hereunder are subject to the provisions of the Intercreditor Agreement dated as of January 31, 2005 (as amended, modified or supplemented from time to time in accordance with the terms thereof, the "***Intercreditor Agreement***") among Ascend Media Holdings, LLC ("***Holdings***"), MW Acquisition Co., Inc., a wholly owned subsidiary of the Holdings ("***MWA***") which as part of the consummation of the Transaction (as defined in the Credit Agreement referred to below) is to merge into Medical World Communications, Inc., which will be the surviving entity of such merger (MWA (or, following such merger, such surviving entity) being referred to herein as the "***Subsidiary Borrower***", and each of Holdings and the Subsidiary Borrower individually, a "***Borrower***" and collectively, the "***Borrowers***"), the Subsidiary Guarantors (as defined therein) and Wells Fargo Bank, National Association, as First Lien Administrative Agent and First Lien Collateral Agent, and as Second Lien Administrative Agent and Second Lien Collateral Agent.

## SECOND LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT

This SECOND LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*IP Security Agreement*") dated as of January 31, 2005 is made by the Persons listed on the signature pages hereof (collectively, the "*Grantors*") in favor of Wells Fargo Bank, National Association ("*Wells Fargo*"), as collateral agent (the "*Collateral Agent*") for the Secured Parties (as defined in the Credit Agreement referred to below).

WHEREAS, Ascend Media Holdings, LLC, a Delaware limited liability company ("*Holdings*") and MW Acquisition Co., Inc., a corporation organized under the laws of the State of Delaware and a wholly-owned subsidiary of Holdings ("*MWA*") which as part of the Transaction (as defined in the Credit Agreement referred to below) is to merge into Medical World Communications, Inc., a corporation organized under the laws of the State of Delaware, which will be the surviving entity of such merger (MWA (or, following such merger, such surviving entity) being referred to herein as the "*Subsidiary Borrower*", and each of Holdings and the Subsidiary Borrower individually, a "*Borrower*" and collectively, the "*Borrowers*") have entered into a Second Lien Credit Agreement dated as of January 31, 2005 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*"), together with Wells Fargo Bank, National Association, as Administrative Agent and as Collateral Agent, the Lenders party thereto, Wells Fargo and CIBC World Markets Corp. ("*CIBC*") as Co-Lead Arrangers and Joint Bookrunners and CIBC as Syndication Agent. Terms defined in the Credit Agreement and not otherwise defined herein are used herein as defined in the Credit Agreement.

WHEREAS, as a condition precedent to the making of Term Advances and by the Lenders under the Credit Agreement and the entry into Secured Hedge Agreements by the Hedge Banks from time to time, each Grantor has executed and delivered that certain Second Lien Security Agreement dated as of January 31, 2005 made by the Grantors to the Collateral Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Security Agreement*").

WHEREAS, under the terms of the Security Agreement, the Grantors have granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantors, and have agreed as a condition thereof to execute this IP Security Agreement for recording with the U.S. Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

**SECTION 1. Grant of Security.** Each Grantor hereby grants to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in all of such Grantor's right, title and interest in and to the following (the "*Collateral*"):

- (i) the patents and patent applications set forth in Schedule A hereto (the "*Patents*");

(ii) the trademark and service mark registrations and applications set forth in Schedule B hereto (provided that no security interest shall be granted in United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law), together with the goodwill symbolized thereby (the "*Trademarks*");

(iii) all copyrights, whether registered or unregistered, now owned or hereafter acquired by such Grantor (the "*Copyrights*");

(iv) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;

(v) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

(vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing.

SECTION 2. Security for Obligations. The grant of a security interest in, the Collateral by each Grantor under this IP Security Agreement secures the payment of all Obligations of such Grantor now or hereafter existing under or in respect of the Loan Documents, whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, indemnifications, contract causes of action, costs, expenses or otherwise.

SECTION 3. Recordation. Each Grantor authorizes the Commissioner for Patents and the Commissioner for Trademarks to record, and hereby requests that it record, this IP Security Agreement.

SECTION 4. Execution in Counterparts. This IP Security Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.


SECTION 5. Grants, Rights and Remedies. This IP Security Agreement has been entered into in conjunction with the provisions of the Security Agreement. Each Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Collateral Agent with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.

**SECTION 6. Governing Law.** This IP Security Agreement shall be governed by, and construed in accordance with, the law of the State of New York.


