**FIRST AMENDMENT TO  
COLLATERAL ASSIGNMENT OF PATENTS AND TRADEMARKS**

THIS FIRST AMENDMENT TO COLLATERAL ASSIGNMENT OF PATENTS AND TRADEMARKS ("First Amendment"), dated November 6, 2007, is by Rocket Gaming Systems, LLC, a Delaware limited liability company (the "Assignor"), in favor of BANK OF AMERICA, N.A., a national banking association (the "Assignee").

**RECITALS**

A. Assignor's predecessor in interest ELINK, L.L.C., an Oklahoma limited liability company, and Assignee entered into that certain Collateral Assignment of Patents and Trademarks dated as of June 28, 2006 (the "Collateral Assignment").

B. Pursuant to Section 13 of the Collateral Assignment, the Collateral Assignment inures to the benefit of and is binding upon the respective successors and permitted assigns of the Assignor and the Assignee.

C. As of January 1, 2007, ELINK, L.L.C. merged into Assignor (the "Merger").

D. Exhibit A to the Collateral Assignment contains a list of all the Patents and Patent Applications (as such term is defined in the Collateral Assignment) owned by the Assignor.

E. Exhibit B to the Collateral Assignment contains a list of all the Trademarks (as such term is defined in the Collateral Assignment) owned by the Assignor.

F. Pursuant to Sections 4 and 12 of the Collateral Assignment, Assignee is authorized to update Exhibit A and Exhibit B to the Collateral Assignment to reflect new Trademarks, Patents and Patent Applications and that subsequent to execution of the Collateral Assignment, Assignor acquired the Trademarks, Patents and Patent Applications as a result of the Merger, without the need to obtain Assignor's written agreement.

NOW, THEREFORE, to include the Trademarks acquired subsequent to execution of the Collateral Assignment and to reflect the current status of each Trademark, Patent and Patent Application as a result of the Merger:


1. Assignee hereby amends Exhibit A to the Collateral Assignment by replacing the original Exhibit A with the Amended Exhibit A attached hereto.
