TRADEMARK RELEASE

THIS TRADEMARK RELEASE (this "Release") is given as of this 31 day of August, 2007 by Wells Fargo Bank, National Association ("Assignor"), to Medical World Communications, Inc., Ascend Media Holdings, LLC ("Holdings"), Ascend Media Medical and Healthcare, LLC, Ascend Media, LLC, IMED Communications, LLC, Ascend Media Agency, LLC, Ascend Media Professional Services, LLC, Medical World Business Press, Inc., Romaine Pierson Publishers, Inc., Curant Communications, Inc., Stagnito Communications Incorporated, Medical World Developmental, LLC, and Practice Builder Organization, Inc. (collectively, along with their successors, the "Assignees") as follows:

WHEREAS, pursuant to the terms and conditions of (i) the Amended and Restated First Lien Credit Agreement dated as of March 16, 2005 among Holdings, Medical World Communications, Inc. (together with Holdings, the "Borrower"), the Assignor and the other banks, financial institutions and other institutional lenders named therein (as amended, the "First Lien Credit Agreement") and (ii) the Amended and Restated Second Lien Credit Agreement dated as of March 16, 2005 among the Borrower, the Assignor and the other banks, financial institutions and other institutional lenders named therein (as amended, the "Second Lien Credit Agreement"), Assignor and Assignees entered into a First Lien Intellectual Property Security Agreement and a Second Lien Intellectual Property Security Agreement, both dated as of January 31, 2005 (the "Security Agreements"), which were recorded in the United States Patent and Trademark Office on February 11, 2005 at Reel/Frame 3119/0692 and Reel/Frame 3125/0001, pursuant to which Assignees granted to Assignor security interests in the Trademarks (as defined in the Security Agreements, the "Trademarks"), including without limitation the trademarks and applications identified in Exhibit A to this Release (the "Released Trademarks"), as collateral security for the prompt and complete payment and performance when due, whether at the stated maturity, by acceleration, upon one or more dates set for prepayment or otherwise of the Obligations (as defined in the Security Agreements, the "Obligations");


