## SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT

THIS SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT (the "Supplement"), is dated December 19, 2007, in favor of **BANK OF AMERICA, N.A.**, a national banking association having an office at 777 Main Street, Hartford, Connecticut 06115, as Administrative Agent (together with any successor thereto appointed pursuant to Section 9.06 of the Credit Agreement referred to below, "Agent").

This Supplement supplements that certain Trademark Security Agreement dated December 27, 2006, and recorded February 12, 2007 Reel/Frame 003479/0620 (the "**Original Agreement**"), by **BOB'S DISCOUNT FURNITURE, LLC**, a Massachusetts limited liability company ("**Debtor**"), in favor of Agent for itself and the other Lenders which are or may become parties to the Credit Agreement dated December 27, 2006, by and among the Debtor, Bob's Discount Furniture of Massachusetts, LLC, Furniture North, LLC, the Agent and the Lenders named therein, as amended, restated, extended, supplemented or otherwise modified in writing from time to time.


As part of the Original Agreement, Debtor has granted Agent a first priority security interest in the Collateral (as defined therein), including Collateral in which Debtor owns, acquires or develops an interest after the date of the Original Agreement. Pursuant to Section 6 of the Original Agreement, Debtor has authorized Agent to from time to time unilaterally modify the Original Agreement by amending Schedule A to include new trademark rights in which Debtor obtains rights. Debtor has notified Agent of its ownership rights to Trademark Registration No. 3355727 for the trademark "BOB-O-PEDIC".

Pursuant to Section 6 of the Original Agreement, Agent hereby supplements and amends Schedule A to the Original Agreement by replacing it in its entirety with Schedule A attached hereto.


