EXHIBIT A

Form of Assignment Agreement

WHEREAS, Dolphin Medical, Inc., a California corporation, ("Assignor"), is the owner of the trademarks, trademark registrations and trademark applications in the form more fully described in Exhibit A hereto (the "Marks");

WHEREAS, Assignor desires to assign the ITU Mark as part of the portion of the business to which the ITU Mark pertains as required by § 10 of the Lanham Act and Assignee desires to receive all of Assignor's right, title and interest in and to the ITU Mark, together with the portion of the business to which the ITU Marks pertain and the goodwill associated therewith.


NOW THEREFORE, for the sum of \$10.00, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, transfers, assigns and sets over unto Assignee, its successors and assigns, all of Assignor's entire right, title and interest in and to the Marks, in the United States of America and any foreign countries, together with the goodwill associated therewith, and together with the portion of the business to which the ITU Marks pertain and symbolized by the ITU Marks, all common law rights related to the Marks, all rights of registration, renewal and extension, and the right to recover for damages and profits for past infringements thereof.


Assignor agrees to execute and deliver at the request of Assignee all papers, instruments, and assignments, and to perform any other reasonable acts Assignee may request in order to vest all of Assignor's right, title, and interest in and to the Marks in Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.
