CONFIRMATORY ASSIGNMENT

WHEREAS, Dana Corporation, a Virginia corporation, with its principal place of business at 4500 Dorr Street, Toledo, Ohio, 43615 ("Assignor"), assigned and transferred, effective March 9, 2007, to Mahle Technology, Inc., a Delaware corporation, with its principal place of business at 23030 Haggerty Road, Farmington Hills, Michigan 48335 ("Assignee"), the entire right, title and interest in and to those marks listed on the attached Schedule A as part of a sale of the ongoing business to which the marks pertain, and all other rights and privileges provided under the trademark and other laws of the United States, the individual states thereof and jurisdictions foreign thereto with respect to the foregoing; the GOODWILL of the business in which the marks are used; and any and all renewals thereof, together with the right to bring suit and collect for past infringements thereof (collectively, the "Trademark Rights"); and;

WHEREAS, the parties wish to ratify and confirm the above-stated assignment and transfer;

NOW, THEREFORE, in view of the payment of Ten Dollars (\$10.00), and other legally sufficient and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Assignor, Assignor assigns and transfers, effective March 9, 2007 to Assignee, all right, title and interest in and to the Trademark Rights.

Assignor shall, without further consideration, execute any additional documents and take such further action as may be requested to vest in Assignee good, valid and marketable title to the Trademark Rights. In the event of a conflict between this assignment and the asset purchase agreement involving the Trademark Rights, the asset purchase agreement shall control.

This Assignment and all terms hereof shall be binding upon and shall inure to the benefit of the parties and their respective heirs, personal and legal representatives, successors and assigns.
