
RELEASE OF SECURITY INTEREST

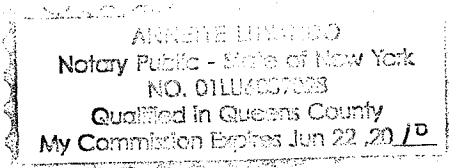
