## SUPPLEMENT NO. 1

SUPPLEMENT NO. 1 dated as of December 21, 2007 (this "**Supplement**"), to the Pledge and Security Agreement dated as of May 25, 2007 (the "**Security Agreement**"), among Amscan Holdings, Inc., a Delaware corporation (the "**Borrower**"), AAH Holdings Corporation, a Delaware corporation ("**Holdings**"), each Subsidiary of the Borrower party from time to time thereto (each such Subsidiary individually a "**Subsidiary Party**" and collectively, the "**Subsidiary Parties**"; the Subsidiary Parties, Holdings and the Borrower are referred to collectively herein as the "**Grantors**"), Bank of America, N.A., as collateral agent (in such capacity, the "**Collateral Agent**"), and Credit Suisse, as administrative agent (in such capacity, the "**Administrative Agent**").

A. Reference is made to the ABL Credit Agreement dated as of May 25, 2007, as amended by Amendment No. 1 dated as of November 2, 2007 to the ABL Credit Agreement, (as further amended, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among Holdings, the Borrower, the Subsidiary Parties, the lenders from time to time party thereto, the Administrative Agent and the Collateral Agent.

B. Capitalized terms used herein and not otherwise defined herein shall have the meanings assigned to such terms in the Credit Agreement and the Security Agreement referred to therein.

C. The Grantors have entered into the Security Agreement in order to induce the Lenders to make Loans. Section 7.12 of Security Agreement and Section 5.12 of the Credit Agreement provide that additional Domestic Subsidiaries of the Borrower may become Subsidiary Parties under the Security Agreement by execution and delivery of an instrument in the form of this Supplement. Each of the undersigned, Factory Card & Party Outlet Corp. ("**FCPO**"), a subsidiary of the Borrower, and Factory Card Outlet of America LTD., a subsidiary of FCOP, (together, the "**New Subsidiaries**") is executing this Supplement in accordance with the requirements of the Credit Agreement to become a Subsidiary Party under the Security Agreement in order to induce the Lenders to make additional Loans and as consideration for Loans previously made.

Accordingly, each Agent and each New Subsidiary agrees as follows:

SECTION 1. In accordance with Section 7.12 of the Security Agreement, each of the New Subsidiaries by its signature below becomes a Subsidiary Party and a Grantor under the Security Agreement with the same force and effect as if originally named therein as a Subsidiary Party and each of the New Subsidiaries hereby (a) agrees to all the terms and provisions of the Security Agreement applicable to it as a Subsidiary Party and Grantor thereunder and (b) represents and warrants that the representations and warranties made by it as a Grantor

thereunder are true and correct in all material respects on and as of the date hereof. In furtherance of the foregoing, each of the New Subsidiaries, as security for the payment and performance in full of the Secured Obligations, does hereby create and grant to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, their successors and assigns, a security interest in and Lien on all of such New Subsidiary's right, title and interest in and to the Collateral such New Subsidiary. Each reference to a "Grantor" in the Security Agreement shall be deemed to include each of the New Subsidiaries. The Security Agreement is hereby incorporated herein by reference.

SECTION 2. Each of the New Subsidiaries represents and warrants to the Collateral Agent and the other Secured Parties that this Supplement has been duly authorized, executed and delivered by it and constitutes its legal, valid and binding obligation, enforceable against it in accordance with its terms, except as enforcement may be limited by bankruptcy, insolvency or similar laws and except insofar as enforcement thereof is subject to general principles of equity.

SECTION 3. This Supplement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. This Supplement shall become effective when the Collateral Agent shall have received a counterpart of this Supplement that bears the signature of each of the New Subsidiaries and the Collateral Agent has executed a counterpart hereof. Delivery of an executed signature page to this Supplement by facsimile transmission shall be as effective as delivery of a manually signed counterpart of this Supplement.

SECTION 4. The New Subsidiaries hereby represent and warrant that (a) set forth on Schedule I attached hereto is a true and correct schedule of the location of any and all material Collateral the New Subsidiaries (other than in-transit inventory), (b) set forth on Schedule II attached hereto is a true and correct schedule of all the Pledged Collateral the New Subsidiaries, (c) set forth on Schedule III attached hereto is a true and correct schedule of all Patents, Trademarks and Copyrights the New Subsidiaries and (d) set forth under its signature hereto, is the true and correct legal name the New Subsidiaries, their jurisdictions of formation and the location of their chief executive office.

SECTION 5. Except as expressly supplemented hereby, the Security Agreement shall remain in full force and effect.

**SECTION 6. THIS SUPPLEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.**

SECTION 7. In case any one or more of the provisions contained in this Supplement should be held invalid, illegal or unenforceable in any respect, the validity, legality and enforceability of the remaining provisions contained herein

and in the Security Agreement shall not in any way be affected or impaired thereby (it being understood that the invalidity of a particular provision in a particular jurisdiction shall not in and of itself affect the validity of such provision in any other jurisdiction). The parties hereto shall endeavor in good-faith negotiations to replace the invalid, illegal or unenforceable provisions with valid provisions the economic effect of which comes as close as possible to that of the invalid, illegal or unenforceable provisions.

SECTION 8. All communications and notices hereunder shall be in writing and given as provided in Section 7.01 of the Security Agreement.

SECTION 9. Each of the New Subsidiaries agrees to reimburse the Collateral Agent for its reasonable out-of-pocket expenses in connection with this Supplement, including the reasonable fees, other charges and disbursements of counsel.

IN WITNESS WHEREOF, each of the New Subsidiaries and each Agent have duly executed this Supplement to the Pledge and Security Agreement as of the day and year first above written.
