ASSIGNMENT AND ASSUMPTION OF ASSETS

THIS ASSIGNMENT AND ASSUMPTION OF ASSETS (this "Assignment") is made as of the 1st day of April, 2007, by and between THERMAL DYNAMICS CORPORATION, a Delaware corporation having an address of 16052 Swingley Ridge Road, Suite 300, Chesterfield, MO 63017 ("Assignor") and VICTOR EQUIPMENT COMPANY, a Delaware company having an address of 16052 Swingley Ridge Road, Suite 300, Chesterfield, MO 63017 ("Assignee").

WITNESSETH:

WHEREAS, Assignor acquired all of the assets of Thermal Arc, Inc., a Delaware corporation wholly owned by Assignor ("Thermal Arc"), pursuant to a merger of Thermal Arc into Assignor effective as of April 1, 2007 (the "Merger"); and

WHEREAS, Assignor is a wholly owned subsidiary of Assignee; and

WHEREAS, Assignor is willing to assign to Assignee and Assignee desires to assume all of Assignor's right, title and interest in and to all of the assets of Thermal Arc that were acquired by Assignor pursuant to the Merger, a list and description of which are attached hereto and incorporated herein as Exhibit A (individually, an "Asset," and collectively the "Assets").

NOW THEREFORE, in consideration of \$1.00 paid by each of the parties hereto to the other and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:


1. Assignor hereby transfers, assigns, conveys and sets over unto Assignee all of Assignor's right, title and interest in, to and under the Assets.
2. Assignee hereby accepts the foregoing assignment of the Assets and hereby assumes and agrees to perform and be bound by all of the covenants, conditions and obligations of Assignor under any contract or agreement that is considered an Asset and which was to be performed or complied with by Assignor thereunder after the date of this Assignment.
3. This Assignment shall be binding on Assignee and Assignor and their respective successors and assigns.


