

Bankers Trust Company hereby acknowledges that as of the date hereof it is the sole lender under the Note Agreement. Bankers Trust Company hereby further acknowledges that upon receipt of the above-mentioned \$15,278,742.81, the Obligations (as such term is defined in the Note Agreement) will be paid and satisfied in full. Bankers Trust Company hereby further confirms that it has no liens, security interests or encumbrances, either individually or in its capacity as Collateral Agent, under the Override Agreement (as that term is defined in the Note Agreement), as the same may have been restated, amended, modified, or supplemented. Notwithstanding the foregoing, Bankers Trust Company hereby preserves all indemnities, and all rights for the payment of expenses, under or in connection with the Note Agreement, the other Loan Documents or the Override Agreement. Bankers Trust Company agrees to execute and deliver to Donald J. Trump, at Donald J. Trump's expense, such other and further documents and instruments as Donald J. Trump may reasonably request to effect the terms of this Satisfaction and Release.
