**RELEASE OF
TRADEMARK SECURITY AGREEMENT**

WHEREAS, ENGINEERED MACHINED PRODUCTS, INC., a Michigan corporation ("EMP"), by a Trademark Security Agreement, dated as of October 10, 2002, and recorded on October 29, 2002 in Reel 002611 at Frame 0398 with the Assignment Division of the United States Patent and Trademark Office (the "Security Agreement"), conveyed to GENERAL ELECTRIC CAPITAL CORPORATION, as Agent ("Agent"), certain trademarks and licenses (the "Collateral") to secure all of the obligations of EMP under that certain Credit Agreement, dated as of October 10, 2002, by and among EMP, the other credit parties signatory thereto, Agent, and the lenders party thereto from time to time (as amended and restated and otherwise amended and supplemented through the date hereof, the "Credit Agreement"); and

WHEREAS, EMP requested that Agent fully release the lien of the Security Agreement.

NOW, THEREFORE, the undersigned, present holder and legal owner of the Security Agreement does hereby RELEASE (without representation, warranty or recourse of any kind) all of Agent's right, title and interest in and to the Collateral under, through or by virtue of the Security Agreement, including, without limitation, the Collateral identified on Exhibit A hereto.
