**AMENDMENT TO MEMORANDUM OF SECURITY AGREEMENT  
PATENTS AND TRADEMARKS**

THIS AMENDMENT TO MEMORANDUM OF SECURITY AGREEMENT -- PATENTS AND TRADEMARKS (this "Amendment"), is dated as of January 29th, 2008, and amends that certain Memorandum of Security Agreement -- Patents and Trademarks, dated as of May 11, 2007 ("Memorandum"), executed by JAFRA COSMETICS INTERNATIONAL, INC., a Delaware corporation ("*JCI*"), in accordance with that certain Security Agreement dated as of May 11, 2007 (as the same may be amended, supplemented or otherwise modified from time to time, the "*Security Agreement*"), among JCI, each subsidiary of JCI listed on Schedule I to the Security Agreement and each Domestic Subsidiary acquired or organized after the date of the Security Agreement that has become a party to the Security Agreement as a Grantor, and BANK OF AMERICA, N.A., a national bank organized under the laws of the United States (in such capacity, the "*Collateral Agent*") for the Secured Parties (as defined therein). Pursuant to the Security Agreement, JCI has granted to the Collateral Agent a continuing security interest in, and a continuing lien upon, all of JCI's right, title and interest in and to the additional trademarks listed on the attached Schedule I hereto, together with the goodwill connected with the use of and symbolized by each of such trademarks, and all renewals thereof, and in the patents listed on Schedule II hereto. Such security interest and lien can be terminated only in accordance with the terms of the Security Agreement.
