## TRADEMARK ASSIGNMENT

THIS ASSIGNMENT, effective as of the 31<sup>st</sup> day of December 2007, is by and between Maple Chase Company, a Delaware corporation (the "Assignor"), and Robertshaw Controls Company, a Delaware corporation (the "Assignee").

WHEREAS, the Assignor has entered into a Stock Purchase Agreement dated as of December 19, 2007 by and among the Assignor, Ranco Incorporated of Delaware, and Walter Kidde Portable Equipment Inc. (the "Purchase Agreement"); capitalized terms used but not otherwise defined herein shall have the meanings assigned to them in the Purchase Agreement;

WHEREAS, the Assignor owns certain trademarks that are unrelated to the Business (defined below) being purchased by the Buyer pursuant to the Purchase Agreement, which trademarks are listed on Schedule A attached hereto (the "Trademarks");

WHEREAS, this Assignment is the "Trademark Assignment" contemplated by Section 6 of the Excluded Assets Assignment (referenced in Section 6.8 of the Purchase Agreement) for the purpose of transferring to the Assignee certain trademarks of the Assignor that are unrelated to the Business; and

WHEREAS, the Parties desire to enter into this Assignment to transfer and assign the trademarks set forth on Schedule A hereto and all goodwill associated therewith (the "Trademarks") to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor hereby assigns to the Assignee all its rights, title and interest in and to the Trademarks, including all rights to collect all royalties and income generated therefrom, the right to sue and recover for past infringement, the goodwill represented by the Trademarks, and the certificates of registration of the Trademarks.

Assignor agrees to execute and deliver to Assignee such further assignments and related documents, with respect to the Trademarks, as Assignee shall reasonably request (at Assignee's expense). All questions concerning the construction, validity and interpretation of this Assignment and the schedules hereto shall be governed by the internal law (but not the law respecting conflicts of law) of the State of Illinois. This Assignment may be signed in one or more counterparts, each of which shall be an original and all of which shall be considered one and the same assignment. Signatures by fax shall be binding.



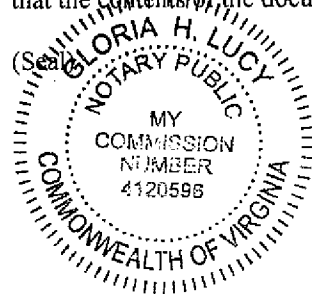
