Partial Release of Security Interest in Trademarks


This Partial Release of Security Interest in Trademarks (the "Partial Release"), dated as of February 6, 2008, is in favor of Grantor (as defined below) made by General Electric Capital Corporation, in its capacity as agent (the "Agent") for the Lenders pursuant to the Credit Agreement, dated as of December 7, 2007, among the Agent, the financial institutions listed therein as Lenders, Taylor-Wharton International LLC, a Delaware limited liability company, having its address at 4718 Old Gettysburg Road, Mechanicsburg, PA 17055 ("Grantor") and the other credit parties party thereto, as amended, amended and restated, supplemented or otherwise modified from time to time.

WHEREAS, Grantor entered into a Trademark Security Agreement, dated as of December 7, 2007 (the "Trademark Security Agreement"), and which was recorded on December 29, 2007 in the United States Patent and Trademark Office (the "PTO") at Reel 003686, Frame 0789, pursuant to which Grantor granted to the Agent a security interest in and lien on all right, title and interest of the Grantor in certain Trademarks (as defined therein), including the Trademarks set forth on Schedule A attached hereto (the Trademarks set forth on Schedule A attached hereto are herein referred to as the "Released Trademarks"), to secure the performance of certain obligations;

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks (but the Agent does hereby expressly reserve and retain all of its right, title, interest and liens granted by the Trademark Security Agreement in all Trademark Collateral (as defined in the Trademark Security Agreement), including Trademarks, other than the Released Trademarks).
