**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This Release of Security Interest in Trademarks (the "Release"), dated as of February ~~24~~, 1997, is made by The Chase Manhattan Bank (formerly known as Chemical Bank), a New York banking corporation, as administrative agent (in such capacity the "Administrative Agent"), for the several banks and other financial institutions from time to time parties to the Revolving Credit Agreement, dated as of August 16, 1993 and amended and restated as of July 17, 1995 (as amended and restated and as the same may have been further amended, supplemented, waived or otherwise modified prior to the date hereof), among each of the subsidiaries of Specialty Foods Corporation signatory thereto, the several banks and other financial institutions from time to time parties thereto and the Administrative Agent, in favor of Gai's Seattle French Baking Company, a Washington corporation ("Grantor").

WHEREAS, Grantor entered into a Revolving Credit Trademark Security Agreement, dated as of August 16, 1993, and recorded in the Patent and Trademark Office (the "PTO") as of September 2, 1993 at Reel/Frame 1030/0294, and a Security Agreement, dated as of August 16, 1993, pursuant to which Grantor granted a security interest to the Administrative Agent in the trademarks set forth on Schedule A attached hereto, and all trademarks acquired thereafter (the "Released Trademarks"), to secure the performance of certain obligations; and

WHEREAS, Grantor has requested that the Administrative Agent release any and all interest it may have in the Released Trademarks, and the Administrative Agent has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, and pursuant to the provisions of the Revolving Credit Trademark Security Agreement and the Security Agreement, the Administrative Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed as of the date hereinabove set forth.
