RELEASE OF LIEN ON TRADEMARKS

This RELEASE OF LIEN ON TRADEMARKS (the "Release"), dated as January 17, 2008 is made by UBS AG, STAMFORD BRANCH, in its capacity as Collateral Agent ("Agent") for the financial institutions party to that certain Fifth Amended and Restated Credit Agreement of Ply Gem Industries, Inc., dated as of February 12, 2004, first amended and restated as of March 3, 2004, second amended and restated as of August 27, 2004, third amended and restated as of February 24, 2006, fourth amended and restated as of October 31, 2006 and further amended and restated as of April 5, 2007, among Ply Gem Industries, Inc. ("Ply Gem"), the financial institutions party thereto and Agent (the "Credit Agreement"), in favor of PLY GEM PACIFIC WINDOWS CORPORATION, a Delaware corporation ("Grantor"). Capitalized terms used herein and not otherwise defined shall have the meaning set forth in or incorporated by reference into the Credit Agreement.

WHEREAS, Grantor entered into a Trademark U.S. Security Agreement, dated as of October 3, 2007 and recorded in the United States Patent and Trademark Office as of December 5, 2007 at Reel 003672, Frame 0011, pursuant to which Grantor granted to Agent a security interest in and lien on all right, title and interest of the Grantor in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks");

WHEREAS, Grantor has requested that Agent release any and all interest it may have in the Released Trademarks, and Agent has agreed to do so, in connection with a permitted Asset Sale pursuant to Section 6.06(b) of the Credit Agreement and a subsequent release of Pledged Collateral (as defined in the Security Agreement) pursuant to Section 11.4 of that certain Amended and Restated U.S. Security Agreement, dated as of February 12, 2004, as amended and restated as of March 3, 2004 and October 31, 2006, and as further amended and restated as of April 5, 2007, by and among Ply Gem, the guarantors party thereto and Agent (the "Security Agreement").

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.
