NUNC PRO TUNC ASSIGNMENT

WHEREAS, CITICASTERS CO., an Ohio corporation ("ASSIGNOR"), having its principal place of business at 3400 Riverside Drive, #800, Burbank, California 91501 F/K/A Citicasters Licenses, Inc., an Ohio corporation, has adopted, used, and has been using the mark listed on the attached Exhibit "A"; and

ASSIGNOR represents and warrants that it has not previously assigned, licensed, or conveyed any interest in said Mark or the other rights referenced herein, and ASSIGNOR agrees to execute any further lawful documents needed to give full force and effect to this instrument.

Executed this 13th day of March, 2008, and made effective as of October 16, 2002.

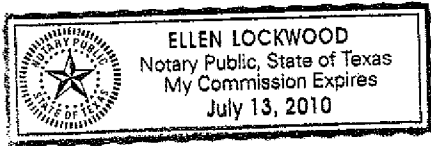
