**GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, WESTLAKE INDUSTRIES, INC., an Illinois corporation (the "Grantor") with principal offices at 1072 Boulder Road, Greensboro, North Carolina 27409, hereby grants to DEUTSCHE BANK AG, LONDON BRANCH, as Security Agent pursuant to that certain Intercreditor Agreement dated as of June 19, 2007 and related to that certain Senior Revolving Credit Agreement dated as of June 19, 2007, with principal offices at Winchester House, 1 Great Winschester Street, London EC2N 2DB (the "Grantee"), a security interest in (i) all of the Grantor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks; (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT is made to secure the satisfactory performance and payment of all the Obligations of the Grantor, as such term is defined in the Security Agreement among the Grantor, the other assignors from time to time party thereto and the Grantee, dated as of June 19, 2007 (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement"). Upon the occurrence of the Termination Date (as defined in the Security Agreement), the Grantee shall execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Marks acquired under this Grant.




