RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE, dated as of July 19, 2000 is made by Fleet National Bank, a national banking association, having its office at 100 Federal Street, Boston, MA 02110, as successor to The First National Bank of Boston ("Secured Party Lender"), and Intirion Corporation, as successor to Microfridge, Inc. ("Borrower"), a Delaware corporation having its principal place of business at 10 Walpole Park South, Walpole, Massachusetts 02081.

WHEREAS, the Borrower and the Secured Party Lender (by their respective predecessors in interest) entered into a certain Loan and Security Agreement dated as of October 8, 1992 between The First National Bank of Boston and Microfridge, Inc. (the "Credit Agreement"), pursuant to which the Secured Party Lender extended credit to the Borrower; and

WHEREAS, the Borrower and the Secured Party Lender (by their respective predecessors in interest) also entered into a Patent and Trademark Security Agreement dated October 8, 1992 ("Patent and Trademark Security Agreement") pursuant to which the Borrower in order to secure the payment, performance and observance of the Borrower's obligations to Secured Party Lender pursuant to the Credit Agreement, granted the Secured Party Lender a security interest in all the Borrower's right, title and interest in and to the Intellectual Property Collateral (as defined therein); and

NOW, THEREFORE, in consideration of the mutual premises and covenants set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Borrower and the Secured Party Lender hereby agree as follows:

1. The Secured Party Lender hereby **RELEASES** all of its security interest in the Intellectual Property Collateral listed in Schedule A attached hereto and any other Intellectual Property Collateral described in the aforementioned Patent and Trademark Security Agreement.

2. The Secured Party Lender agrees to cooperate with the Borrower and to provide the Borrower with any documentation, information and additional authorization necessary to effect and record the release of the Secured Party Lender's security interest in all Intellectual Property Collateral.

IN WITNESS WHEREOF, the Secured Party Lender has caused this Release to be duly executed under seal by an officer thereunto duly authorized as of the date first written hereinabove.
