## ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY INTEREST

ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY INTEREST, dated as of February 20, 2008 (this "Assignment"), made by ICF INTERNATIONAL, INC., a Delaware corporation, ICF CONSULTING GROUP, INC., a Delaware corporation each of their direct and indirect subsidiaries party hereto, and each other "Borrower" party from time to time to the hereinafter defined Loan Agreement (collectively, the "Borrowers") in favor of CITIZENS BANK OF PENNSYLVANIA, a Pennsylvania state chartered bank ("Citizens Bank"), acting in the capacity as Administrative Agent for the hereinafter defined Lenders ("Administrative Agent").

### WITNESSETH:

WHEREAS, pursuant to that certain Second Amended and Restated Business Loan and Security Agreement dated as of February 20, 2008, by and among (a) the Borrowers, (b) the Administrative Agent, (c) Citizens Bank, acting in its capacity as the Swing Line Lender, (d) Citizens Bank and each other "Lender" party thereto from time to time (the "Lenders") and (e) RBS Securities Corporation (d/b/a RBS Greenwich Capital), as sole and exclusive lead arranger and sole and exclusive book running manager (the "Loan Agreement"), and to further evidence the Administrative Agent's lien on the Collateral (as defined in the Loan Agreement), the Borrowers have agreed to execute and deliver this Assignment to the Administrative Agent.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Borrowers hereby agree as follows:

I. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Loan Agreement.


II. GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY. The Borrowers hereby assign and transfer to the Administrative Agent, for the ratable benefit of the Lenders, and hereby grants to the Administrative Agent, for the ratable benefit of the Lenders, a continuing security interest in all of each Borrower's right, title and interest in, to and under all patents, patent applications, trademarks, trademark applications, copyrights, copyright applications, trade names, trade secrets and licenses owned or utilized by such Borrower (collectively, the "Intellectual Property Collateral"), including the patents, patent applications, trademarks, trademark applications, copyrights, copyright applications, trade names, trade secrets and licenses set forth on the Schedule attached hereto.

III. SECURITY AGREEMENT. The security interests granted pursuant to this Assignment are granted in conjunction with the security interests granted to the Administrative Agent, for the ratable benefit of the Lenders, pursuant to the Loan Agreement. The Borrowers hereby acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the security interest in the Intellectual Property Collateral made and granted hereby are more fully set forth in the Loan Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.


