
PARTIAL RELEASE OF FIRST LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT

Reference is made to the First Lien Intellectual Property Security Agreement dated as of December 8, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by BST US Holdings, Inc., a Delaware corporation, BST Safety Textiles, LLC, a Georgia limited liability company, BST Safety Textiles GmbH, a company organized under the laws of Germany, Narricot Industries Management Corp., a Georgia Corporation, and Narricot Industries, L.P., a Georgia limited partnership ("Narricot LP"), as grantors, in favor of Goldman Sachs Credit Partners L.P., as security agent (the "Assignee").


