WHEREAS, pursuant to the Loan and Security Agreements and the Grants of Security Interest in United States Trademarks, Assignees granted to Assignor a continuing security interest in all of such Assignees' right, title and interest in, to and under all of the intellectual property (and all rights therein) of such Assignor, or in which or to which such assignor has any rights, in each case whether then existing or thereafter acquired, including but not limited to the following: (i) all copyrights, including any United States or foreign copyright then or thereafter owned by Assignees, including any registrations of any copyrights, in the United States Copyright Office (the "USCO") or any foreign equivalent office, as well as any application for a copyright registration then or thereafter made with the USCO or any foreign equivalent office by Assignees; (ii) all trademarks, including any trademarks, service marks and trade names then held or thereafter acquired by Assignees, including any registration or application for registration of any trademarks and service marks then held or thereafter acquired by Assignees, which are registered or filed in the PTO or the equivalent thereof in any state of the United States or any equivalent foreign office or agency, as well as any unregistered trademarks and service marks used by Assignees and any trade dress including logos, designs, fictitious business names and other business identifiers used by Assignees, including any of the trademark registrations or applications therefor listed on Schedule A hereto; and (iii) in respect of the foregoing, all contract rights, accounts and other rights to payment (the "Intellectual Property Collateral");




