TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (the "*Assignment*"), dated as of March 9, 2007, is entered into between and among **Dana Corporation**, a corporation organized under the laws of the Commonwealth of Virginia ("*Assignor*") and **MAHLE Technology, Inc.**, a corporation organized under the laws of the State of Delaware ("*Assignee*").

WHEREAS, this Assignment is delivered pursuant to the Closing under the Stock and Asset Purchase Agreement (the "*Purchase Agreement*") dated as of December 1, 2006, between and among Dana Corporation, a corporation organized under the laws of the Commonwealth of Virginia and MAHLE GmbH, a corporation organized under the laws of the Federal Republic of Germany;

WHEREAS, capitalized terms used but not defined in this Assignment shall have the meaning ascribed to them in the Purchase Agreement;

WHEREAS, Assignor has agreed to assign to Assignee all of Assignor's right, title and interest in and to the Trademarks included in the Purchased Intellectual Property owned by Assignor, including without limitation, those marks set forth on Schedule A hereto as well as the appurtenant goodwill (collectively, the "*Assigned Marks*"); and

WHEREAS, the Assigned Marks that were filed in the United States on an intent to use basis ("*ITU Marks*") are being transferred to Assignee with the ongoing and existing part of the Business to which those Trademarks relate.

NOW, THEREFORE, in consideration of the premises set forth above and for other good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby sells, assigns, transfers, sets over and delivers to Assignee, Assignor's entire right, title and interest in and to the Assigned Marks and all associated goodwill (with the exception of the ITU Marks), the same to be held and enjoyed by Assignee, together with all income, royalties, damages or payments due on or after the date of this Assignment, including, without limitation, all claims for damages or payments by reason of infringement, dilution, misappropriation or other violation of the Assigned Marks ("*Violations*"), including the right to sue and collect damages for past Violations.

In the event of a conflict between this Assignment and the Purchase Agreement, the parties agree that the Purchase Agreement shall control.

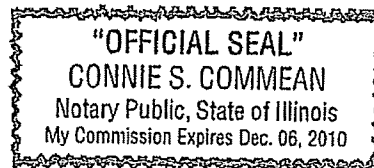
