**ASSIGNMENT OF SECURITY INTEREST IN  
PATENTS AND TRADEMARKS**

This Assignment of Security Interest in Patents and Trademarks dated April 16, 2008, is executed by Credit Suisse, Cayman Islands Branch ("Credit Suisse") in favor of General Electric Capital Corporation, a Delaware corporation ("GECC"), as collateral agent for the Secured Parties described below.

WHEREAS, Credit Suisse ("Assignor"), as original collateral agent under that certain Senior Secured Superpriority Debtor-in-Possession Credit Agreement dated as of January 21, 2008, by and among Quebecor World Inc. and Quebecor World (USA) Inc., as borrowers, the guarantors from time to time party thereto, the lenders from time to time party thereto, and the other parties from time to time party thereto (as amended, modified, supplemented, restated, or replaced, the "Credit Agreement"), has heretofore been granted a security interest in, among other things, (i) the United States patents and patent applications described on the attached Exhibit A (collectively, the "Patents"), and (ii) the trademarks, and all registrations and applications for registration thereof, together with all goodwill symbolized thereby described on the attached Exhibit B (collectively, the "Trademarks") by each of the Grantors named in that certain Intellectual Property Security Agreement dated as of January 21, 2008 (the "Intellectual Property Security Agreement"), given by the Grantors in favor of Assignor for the benefit of the Secured Parties, as defined in the Credit Agreement (the "Secured Parties"), to secure the obligations thereunder and as described therein; and

WHEREAS, the Intellectual Property Security Agreement was filed with the United States Patent and Trademark Office and was recorded as follows:

- (i) as to Patents, on February 01, 2008, at Reel 020451, Frame 0425; and
- (ii) as to Trademarks, on February 01, 2008, at Reel 003710, Frame 0001;



WHEREAS, Assignor desires to assign its rights in the Patents and the Trademarks under the Intellectual Property Security Agreement to GECC, in its capacity as successor collateral agent for the Secured Parties ("Assignee");

NOW, THEREFORE, Assignor does hereby forever and fully assign to Assignee all right, title and interest of Assignor to the Intellectual Property Security Agreement, including the security interests heretofore granted to Assignor by Borrowers in the Patents and Trademarks, which security interests were duly recorded in the United States Patent and Trademark Office, and Assignor hereby consents to the recordation of this Assignment in the records of the United States Patent and Trademark Office.


