TRADEMARK ASSIGNMENT





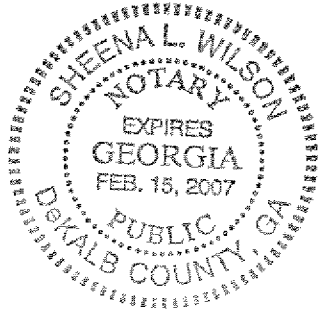
