## NOTICE OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF SECURITY INTEREST IN TRADEMARKS is made the 28th day of April, 2008 from ASSOCIATED BANK, NATIONAL ASSOCIATION, a national banking association (the "Secured Party"), and NORTH AMERICA SPORTS MEDIA, INC., a Delaware corporation (the "Company").

The Company and the Secured Party acknowledge the following:

A. Pursuant to a Guaranty (the "Guaranty") dated as of November 22, 2006, from the Company and Gotickets, Inc. to the Secured Party, the Company and Gotickets, Inc. jointly and severally guaranteed all of the obligations of North America Sports Media Holdings, Inc., a Delaware corporation ("NASM"), under a Credit Agreement dated as of November 22, 2006, as amended to date, by and between the Secured Party and NASM.

B. In connection with the Guaranty, the Company executed a Security Agreement to and for the benefit of the Secured Party, dated as of November 22, 2006 (the "Security Agreement"), pursuant to which the Company collaterally assigned to the Bank certain trademarks.

C. In connection with the acquisition of certain assets from Doddson Travel Agency, Inc. ("Doddson"), pursuant to an Asset Purchase Agreement dated as of March 31, 2008, by and among the Company, Doddson, Christine C. Bruce and Kenneth K. Bruce, the Company acquired an interest in the Trademarks set forth on Exhibit A attached hereto (the "Trademarks").

D. The Company owns the Trademarks, which have been granted by, or applications therefor are pending before, the United States Patent and Trademark Office.

E. The Company has granted to the Secured Party a security interest in the Trademarks upon the terms and conditions set forth in the Security Agreement.
