In the event of a conflict between this Assignment and the Purchase Agreement dated as of June 19, 2007 between C&D Technologies, Inc. and Murata Electronics North America, Inc. (as assignee of Murata Manufacturing Co., Ltd.) (the "Agreement"), the parties agree that the Agreement shall control.
