## TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT, dated as of the 9th day of May, 2008, is made by and between DYNO SEASONAL SOLUTIONS, LLC, a Delaware limited liability company, (the “**Grantor**”), and THE CIT GROUP/COMMERCIAL SERVICES, INC., a New York corporation (the “**Secured Party**”). Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Amended and Restated Financing Agreement, dated as of August 31, 2007, among the Grantor, Dyno LLC, Dyno Decorative Bows LLC, and the Secured Party, as from time to time amended, modified, supplemented or restated (the “**Financing Agreement**”).

WHEREAS, the Grantor has, pursuant to the Financing Agreement granted to the Secured Party a security interest in and to all of the right, title and interest of the Grantor, in, to and under the Collateral, including, without limitation, the Grantor’s Trademarks, as collateral security for the payment and performance in full when due of the Obligations; and


WHEREAS, the Grantor and the Secured Party wish to further memorialize the security interest described above as it relates to the registered and pending U.S. federal trademarks identified in Schedule A, attached hereto, and incorporated herein by this reference (the “**Specified Trademarks**”).

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Grantor hereby grants unto the Secured Party a security interest in and lien on all of its right, title and interest in the Specified Trademarks, as collateral security for the payment and performance in full when due of the Obligations. The Grantor hereby acknowledges and affirms that the rights and remedies of the Secured Party with respect to the security interest in the Specified Trademarks made and granted hereby are more fully set forth in the Financing Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
